Stephen Moore is senior economics writer for the Wall Street Journal editorial page and a member of the Journal's editorial board. Mr. Moore is also an economic commentator for CNBC TV, where he appears twice weekly and for Fox News Channel where he comments regularly on economic and fiscal policy issues. He is also a frequent lecturer to business, investment and university audiences around the world on the U.S. economic and political outlook in Washington, D.C.

From 1999-2004 Mr. Moore served as founder and president of the Club for Growth, a 25,000-member

organization dedicated to helping elect free market, tax cutting candidates to Congress. In his tenure as president, the Club for Growth became one of the most influential and respected political organizations in the nation. From 2003-2004, the Club for Growth raised nearly \$22 million for Republican congressional and Senate candidates, making the Club the biggest single money raiser for Republican candidates outside the party itself. In 2007, he received the Ronald Reagan "Great Communicator" award from the Republican party for his advancement of economic understanding.

Mr. Moore has served as a Senior Economist at the Joint Economic Committee under former Chairman Dick Armey of Texas. There, he advised Mr. Armey on budget, tax, and competitiveness issues. He was also an architect of the famous Armey flat tax proposal. From 1983 through 1987, he served as the Grover M. Hermann Fellow in Budgetary Affairs at the Heritage Foundation. Mr. Moore has worked for two presidential commissions. In 1988, he was a Special Consultant to the National Economic Commission. In 1987, he was research director of President Reagan's Commission on Privatization. Moore is the author of 5 books, including, most recently "The End of Prosperity: How Higher Taxes Will Doom the Economy - If We Let it Happen," which was a nominee for the F.A. Hayek book award in 2009. His books also include: "Its Getting Better All the Time: The 100 Greatest Trends of the Last Century," and "Government: America's Number One Growth Industry." Mr. Moore is a graduate of the University of Illinois and holds an M.A. in Economics from George Mason University.

### Risa Lavizzo-Mourey, M.D., M.B.A.

Dr. Risa Lavizzo-Mourey, president and CEO of the Robert Wood Johnson Foundation, is a national leader in transforming America's health systems so people live healthier lives and receive the health care they need. A practicing physician with business credentials and hands-on experience developing national health policy, Dr. Lavizzo-Mourey was drawn to the Robert Wood Johnson Foundation by the opportunity, as she puts it, to "alter the trajectory and to push society to change for the better."

Dr. Lavizzo-Mourey combines the values she learned as a doctor, a commitment to others, a sense of altruism; with the skills and knowledge from her business training, the importance of measuring results and outcomes, clear accountability and taking a disciplined approach to managing resources and motivating people. Through it all, she is guided by the conviction that philanthropy is about simultaneously improving individual lives, transforming systems and in turn, achieving lasting social change.

She completed a residency in Internal Medicine at Brigham and Women's Hospital in Boston; was a Robert Wood Johnson Clinical Scholar at the University of Pennsylvania; and trained in Geriatrics at Penn. She and her husband of more than 30 years have two adult children.

Charles Powell (Lord Powell of Bayswater KGMG) serves on the Boards and Advisory Boards of a number of British and international companies including Chairman of LVMH Moët Hennessy - Louis Vuitton in the United Kingdom and of the International Advisory Board of Rolls-Royce. Lord Powell is a board member of Caterpillar Inc. and Textron Corporation in the United States, Hong Kong Land Holdings and of the Mandarin Oriental Hotel Group in Bermuda.

Lord Powell co-chairs the government's Asia Task Force with the Business Secretary Vince Cable and was Chairman of both the China-Britain Business Council and the Singapore-British Council for ten years.
