Chris joined McDonald's in 2015 as Executive Vice President, Strategy, Business Development and Innovation. In this role, he worked closely with business leaders and franchisees to identify innovative new ideas and best practices to accelerate system growth. Chris has more than 25 years of experience working in premier global consumer companies. He began his career in brand management at Procter & Gamble, and also held senior positions at PepsiCo, and most recently at Kraft Foods, where he was EVP, Growth Initiatives and President, International.

In addition to serving on the McDonald's Board of Directors, he is also a trustee of Ronald McDonald House Charities. Outside of McDonald's, Chris serves on the Board of Directors for Procter & Gamble

Chris is a proud alumnus of both Duke University and Harvard Business School. He lives in Chicago, IL, with his wife and two kids.

Michael Schwimer CEO, Big League Advance January 26, 2024 Hilton, Naples

Michael Schwimer is the Founder and CEO of Big League Advance ("BLA"). BLA began an investment firm that has raised over \$230M, which it invests in minor league baseball players and NCAA athletes in exchange for an agreed-upon percentage of future earnings should they make it to the major leagues. BLA was Michael's idea of a way to help support players as they navigate

the financial hardships of minor league baseball. Michael, and BLA's team of data scientists, have used statistical modeling to build predictive algorithms to forecast MLB, NBA and NFL success. Big League Advance's first fund invested in 77 players, and more than 50 players have graduated to the MLB (so far) - 80%+ of those players were outside of the top 300 prospects when BLA invested in them. The second fund invested in 378 baseball players, and an additional 6 football players, as BLA began to invest in college athletes in addition to baseball players. BLA began investing its third Fund beginning in June, 2022.

In addition to their work in baseball and football, BLA has been building a variety of statistical models across other major sports for a myriad of uses, including for personnel decisions and in-game applications. In recent years, they have provided analytical consulting services for multiple prominent college basketball programs.

Prior to founding Big League Advance, Michael was a professional baseball player with the Philadelphia Phillies and Toronto Blue Jays organizations. He made his major league debut in August of 2011. Michael holds a B.A. from University of Virginia, where he spent four seasons pitching for the Cavaliers.
